#### CHIEF ADVISORS REPORTS/RECOMMENDATION

Chief Scientist Ram Ramanujam spoke about the cycle of replacement of HPC at LSU that should come online, and he reported that Sam is fully aware and that they have been in discussions regarding looking at configurations from vendors. He also mentioned that they are trying to provide a sufficiently new experimental architecture as a part of the entire system.

Chief Technology Advisor Gene Fields spoke about the transitioning to the trending topics calls. There are lots of discussions on the compliance as well as the technology side of the house.

Gene thanked everyone for all the increased participation that he has seen across the community but asked that everyone continue to urge their counterparts to participate.

Lance Neal added the trending topics came out of the COVID calls that began one year ago and with the communities' input has transitioned to how can we collaborate on pressing and emerging. The most recent call was cancelled but will resume next month.

Chief Economic Development Advisor Paul Helton stated that when COVID hit one of the major initiatives in progress was the Resilient Louisiana Commission which has completed its work with published recommendations at LED.gov. There were a lot of recommendations and changes made.
